

**CITY OF TANEYTOWN
RESOLUTION NO. 2011-11**

WHEREAS, the Charter of the City of Taneytown gives the Mayor and City Council power to establish and collect fees and fines for violations of provisions of the Code of the City of Taneytown; and

WHEREAS, Section 193-23 of the Code of the City of Taneytown states that certain fines and penalties relating to Chapter 193 shall be set by Resolution of the Mayor and City Council of the City of Taneytown; and

WHEREAS, the Mayor and City Council deem it in the best interests of the Citizens of Taneytown to adjust the fines and penalties for said section.

NOW THEREFORE, BE IT ENACTED AND RESOLVED BY THE CITY COUNCIL OF THE CITY OF TANEYTOWN that:

1. The fines and penalties for Article II, Stopping, Standing and Parking and Article III, Metered Parking, of Chapter 193, shall be adopted as shown in the attached Exhibit A.
2. These fines shall become effective immediately.
3. There are other fines that the City charges that are not listed on the attached Exhibit A. These fines shall not be affected by this Resolution and shall continue to remain in full force and effect.
4. Copies of this Resolution and Exhibit A shall be available for distribution to the public upon request.
5. The Fines contained on Exhibit A of this Resolution shall be posted on the City's website to serve as notice to the public of the existing fines.
